## Privacy Policy

### Introduction

#### Welcome to Holy Moly Casinos' privacy notice.

HMC MEDIA LTD ("Holy Moly Casinos", "us", "we", or "our") operates <https://holymolycasinos.com> (the "Site"). By using the Site, you agree to the collection and use of information in accordance with this policy. This Privacy Policy will inform you as to how we look after your personal data when you visit our site and tell you about your privacy rights. By using the Site, you are also agreeing to our Terms of Use. Please make sure you read and agree with our Terms of Use if you want to use our Site.

#### Our Privacy Policy explains:

- The information we collect and why we collect it.
- How we use that information.
- The choices we offer, including how to access, update or delete information.
- How we share that information.

### Information we collect

We collect information in the following ways:

- 1. Information you give us.** While using the Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name, email, birthday, country, gender (personal Information).
- 2. Information we get from your use of the Site.** This information helps to customize the Site and it includes:

#### Device information

We collect device-specific information (such as your hardware model, operating system version and unique device identifiers).

#### Log information

When you use the Site, we automatically collect and store certain information in server logs. This includes: Internet protocol address, device event information such as crashes, system activity, hardware settings, browser type, browser language, the date and time of your request and referral URL., and cookies that may uniquely identify your browser.

#### Location information

When you use the Site, we may collect and process information about your actual location. We use various technologies to determine location, including Internet protocol address, and other sensors.

### **Local storage**

We may collect and store information (including personal information) locally on your device using mechanisms such as browser web storage (including HTML 5) and application data caches.

### **Cookies and similar technologies**

We and our partners use various technologies to collect and store information when you visit the Site, and this may include using cookies or similar technologies to identify your browser or device. It helps analyze the traffic to the Site and our partners websites. You may also set your browser to block all cookies, including cookies associated with our services, or to indicate when a cookie is being set by us. However, it's important to remember that many of our services may not function properly if your cookies are disabled. For example, we may not remember your language preferences.

## **How we use information we collect**

We use, store, and process information, including personal information, about you to provide, understand, improve, and develop the Site and to contact you with newsletters, marketing or promotional materials and other information that is related with the theme of the Site. You will receive marketing communications from us if you have signed up to our Site and you have not opted out of receiving marketing emails. We use information collected from cookies and other technologies, like pixel tags, to improve your user experience and the overall quality of our services.

We will ask for your consent before using information for a purpose other than those that are set out in this Privacy Policy.

## **The choices we offer, including how to access, update or delete information.**

Our goal is to be clear about what information we collect, so that you can make meaningful choices about how it is used.

Whenever you use the Site, we aim to provide you with access to your personal information. If that information is wrong, we strive to give you ways to update it quickly or to delete it – unless we have to keep that information for legitimate business or legal purposes.

We aim to maintain our services in a manner that protects information from accidental or malicious destruction.

## **How we share that information**

### **With your consent**

We will share personal information with companies, organizations or individuals when we have your consent to do so.

### **For external processing**

We provide personal information to our affiliates or other trusted businesses or persons to process it for us, based on our instructions and in compliance with our Privacy Policy and any other appropriate confidentiality and security measures. We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

We may share non-personally identifiable information publicly and with our partners – like publishers, advertisers or connected sites. For example, we may share information publicly to show trends about the general use of the Site.

We process personal information on our servers in many countries around the world. We may process your personal information on a server located outside the country where you live.

If HMC MEDIA LTD is involved in a merger, acquisition or asset sale, we will continue to ensure the confidentiality of any personal information and give affected users notice before personal information is transferred or becomes subject to a different privacy policy.

And we will never sell your personal data to any company for marketing purposes.

### **For legal reasons**

We will share personal information with companies, organizations or individuals if we have a good faith belief that access, use, preservation or disclosure of the information is reasonably necessary to:

- meet any applicable law, regulation, legal process or enforceable governmental request.
- enforce applicable Terms of Use, including investigation of potential violations.
- detect, prevent, or otherwise address fraud, security or technical issues.
- protect against harm to the rights, property or safety of us, our users or the public as required or permitted by law.

### **Information security**

We work hard to protect The Site and our users from unauthorized access to or unauthorized alteration, disclosure or destruction of information we hold. In particular we encrypt our Site using SSL.

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

## Data Retention

Unless otherwise specified, we retain information as long as it is necessary and relevant for us to achieve the purposes referred to above or to enable us to comply with our legal data protection retention obligations. Upon deactivation of your account, we will minimize the personal data we keep about you only to such data which we are required to keep to comply with laws, or other legal reasons. We may keep activity data on a non-identifiable basis to improve our services.

## Other important information

The services offered by Holy Moly Casinos are not directed at children under 18 years old. We do not knowingly collect or solicit personal information from anyone under the age of 18 or knowingly allow such persons to register at the Site (as that term is defined in our Terms of Use. If you are under 18, please do not attempt to register at the Site or send any information about yourself to us. No one under the age of 18 may provide any personal information to us or at the Site. In the event that we learn that we have collected personal information from a child under the age of 18 we will delete that information as quickly as possible.
